Sir,

I do hereby lodge a complaint empowered by the Electricity Act, 2003, read with further amendments that Mr. Dhanesh Roy, S/O- Gathu Roy, Village- Fakdaibari (near Radha Gobinda Bazar), P.O. - Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 412237054), has committed Theft of Electricity under section: 135(i) (a) & 138 (b) of the Electricity Act, 2003, read with further amendments for the Commercial purpose as stated here under.

On 20.02.2023 at about 14:45 Hours, I, Sri Sourav Paul, AE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Amarasish Mohandeo, DE (E) & 2. Mr. Pranab Sikdar, Special Officer, attached with S&LP unit, Darjeeling Region Office, WBSEDCL & 3. Mr. Biplab Sarkar, Sr. Office Executive & 4. Mr. Umesh Subba, Sr.TSH, attached with Subhaspally CCC, WBSEDCL, entered into the Commercial premises of Mr. Dhanesh Roy, S/O- Gathu Roy, Village- Fakdaibari (near Radha Gobinda Bazar), P.O. - Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 412237054), in order to inspect the service line incoming & leaving the meter as well as Supervisory Checking purpose.

During inspection it has been found that the aforesaid accused, Mr. Dhanesh Roy, S/O- Gathu Roy, Village- Fakdaibari (near Radha Gobinda Bazar), P.O. - Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 412237054), was consuming Electricity dishonestly in unauthorized manner by Unauthorized Reconnecting the 'Deemed Disconnected' service connection having Consumer ID: 412237054 & Meter No.: BB0498795 which was disconnected on 10.01.2022. Moreover, the last meter consumption recorded before disconnection was 4160kWH on 10.01.2022 & during inspection on 20.02.2023, the last reading was found 5921kWH dated: 20.02.2023. Thus the service connection was used in unauthorized manner & WBSEDCL incurred huge amount of loss in revenue.

As Theft was detected I immediately with the help of my Technical staff disconnected his Service Connection and seized one number Energy Meter having SI No.: BB0498795, make: Bentec Bhartia, Rating: 240V, 5-30A, 3200 imp/kWH, along with some portion of two numbers each of incoming & outgoing wires which have been used for Unauthorized reconnection of the 'Deemed Disconnected' service connection with the LT Pole side (Consumer ID: 412237054) at the mentioned Commercial premises for the Commercial purposes dishonestly in unauthorized manner under a proper seizure list duly signed by the Inspection Team Members & the Accused Person. The seized articles were properly packed, labeled and sealed at the spot after observing necessary formalities in presence of the Inspection Team Members & the Accused Person. However, Copies of Notice, Inspection Note & Seizure List were handed over to the accused person, Mr. Dhanesh Roy at the inspection spot. The inspection team members left the aforesaid premises at 15:05 Hours on the same day after observing all formalities.

So the accused Mr. Dhanesh Roy, S/O- Gathu Roy, Village- Fakdaibari (near Radha Gobinda Bazar), P.O. - Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 412237054), has committed Theft of Electricity under section: 135(i) (a) & 138 (b) of the Electricity Act, 2003, read with further amendments for the Commercial purpose.

So I request you to take cognizance against the aforementioned accused person on this matter and consider this complain as FIR to initiate further necessary action from your end.
