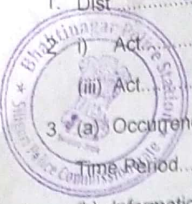

Sub: A Complaint against my brother-in-law, Ranjit Prasad, S/o- Dudhnath Prasad and his wife, Kavita Singh (Prasad) and my father-in-law Doodh Nath Prasad, S/o- not known- all are resident of Bhupendra Nagar, Ward no. 42, S.M.C, P.O- Salugara, P.S- Bhaktinagar, Dist. Jalpaiguri.

Respected Sir,

I, **Smt. Radhika Bhagat (Prasad)**, Wife of Late Nandalal Prasad, Son of Doodh Nath Prasad, residing at Bhupendra Nagar, Ward No. 42, S.M.C, P.O.- Salugara, P.S.- Bhaktinagar, Dist. Jalpaiguri, do hereby lodge a complaint against my brother -in- law, Ranjit Prasad, S/o- Dudhnath Prasad and his wife Kavita Singh (Prasad) and my father-in-law Doodh Nath Prasad, S/o- not known- all are resident of Bhupendra Nagar, Ward No. 42, S.M.C, P.O- Salugara, P.S- Bhaktinagar, Dist. Jalpaiguri, to the effect as follows:

1. That my marriage was solemnized on 25-04-2012 along with one Nandalal Prasad , S/o- Dudhnath Prasad, resident of Bhupendra Nagar, Ward No. 42, S.M.C, P.O- Salugara, P.S- Bhaktinagar, Dist. Jalpaiguri as per Hindu rites a, rituals and customs.
2. That out of the said wedlock one female baby namely Laxmi Prasad was born on 21-09-2013.
3. That my husband said Nanlal Prasad unfortunately expired on 08-04-2019.
4. That since the death of my husband my above named in-laws have been frequently abusing me in most filthy and derogatory languages alleging that I along with my parents have killed my husband and have been committing mental and physical torture upon me and threatening me to quit and vacate my matrimonial home or to face dire consequences.
5. That I have been tolerating all the above cruelty that is verbal, emotional, physical and mental abuses and assaults committing upon me by the aforesaid in- laws but I did not lodge any complaint against them with any authority in the hope and expectations that one day they will understand me and shall change their attitude and behavior towards me but all went in vain.
6. That on 21-02-2023 at about 8:00 a.m. my in- laws said Ranjit Prasad and his wife Kavita Singh (Prasad) hurled abuses in filthy languages and



physically assaulted me with stone and chair and even showered with slaps, fist and blows and kicks on the instigation, incitement of my father-in-law and even aid and abated to commit the aforesaid offence.

7. That due to their physical assault, I sustained cut and bleeding injuries on my left hand and suffered bodily injuries on my person. I was Immediately taken to Siliguri District Hospital by my mother and brother for my treatment.

So, therefore, I humbly request your goodself to take stringent legal action against them and booked the aforesaid persons as per the provision of law at an earliest.

I shall ever remain grateful for the needful and be obliged thereby.
