Subject: Complaint.

Dear Sir,

I, Sri Mahadeb Roy @ Dhip Singh Roy, son of Late Gedu Singh Roy, resident of Papia Para, Naresh More, Post Office - Ghogomali, Police Station- Bhaktinagar, District- Jalpaiguri, Pin- 734005, beg to lodge this complaint as follows:

In the month of January, 2023, I along with my brother received summons of a suit being Title Suit no. 569 of 2022 pending in the court of the Learned Civil Judge Junior Division at Jalpaiguri, from which we gathered that the said false case/ suit has been filed against by Shikha Mondal, wife of Sanjay Mondal resident of Ashighar, District- Jalpaiguri.

Upon going through the contents of the documents of the suit, we found that Shikha Mondal has presumably purchased a piece of land in L.R. Plot no. 205, corresponding to R.S. Plot no. 194 at Mouza- Dabgram, Police Station- Bhaktinagar, District- Jalpaiguri, on the strength of a Power of Attorney being no. I-3922 of 2021 executed by Sri Samir Roy and Smt. Basanti Roy of Telipara, Dabrgram-II.

In the month of February, 2023, we made necessary enquiries in the locality as we sensed a conspiracy hatched by the local land mafia to grab our ancestral land from us in R.S. Plot no. 194, and managed to get a photocopy of the said Power of Attorney being no. I-3922 of 2021. On going through the same, we fell from the sky to see that Samir Roy and Basanti Roy executed a forged and fabricated power of attorney by portraying their father Sri Prafulla Roy, who is still very well alive, as dead in the said document and claiming to be owners of their grandfather's land after their father i.e. Sri Prafulla Roy's death.

Sir we know Sri Prafulla Roy very well and meet him very frequently, but he has been shown to be dead in the aforementioned document by the local land mafia.



Sir, the aforesaid conspiracy has been hatched by many persons to create pressure upon us to leave our ancestral land and succumb to their illegal demands.

A few days ago, I received a phone call from an unknown number and on enquiring, the person from the other end said that he was Sanjay Mondal and he threatened us to arrange Rs. 25 Lakhs within 10 days to withdraw his wife's claim, or else he would bulldoze the property in the early morning and take forcible possession of the same.

Sir Sanjay Mondal is a noted land mafia of our locality and he has also been previously arrested in many similar land grabbing cases and he along with his wife Smt Shikha Mondal and Sri Samir Roy, Smt Basanti Roy and Sri Sonakanta Roy (the executants of General Power of Attorney I-3922 of 2021) and forged the documents aforesaid and are now trying to grab our ancestral land from us by using all criminal means necessary as have been mentioned above.

You are requested to enquire into the matter and take immediate action against said Sanjay Mondal, Smt Shikha Mondal and Sri Samir Roy, Smt Basanti Roy and Sri Sonakanta Roy, by registering a specific case against them.
