On 10th February, <sup>2023</sup> my mother Mrs Dipu Laha purchased medicines namely:  
Oracim C2 and Critical Hax from Siliguri Pharmacy, located in Netaji  
Home, Saha Pally, Siliguri. Since then she has been taking medication.  
Since past few days she started feeling sick and then upon  
examination found that the medicines sold by Siliguri Pharmacy  
had expired since 6 to 8 months namely Oracim C2.

The other medicine also has developed fungus and they are still  
selling those medicines.

I would request you to take necessary steps to ensure that  
such incidents don't happen again with anyone else.
