Sir today morning on 22<sup>nd</sup> Feb 2023 at around 10 am I received a call from some local informer from khaprail road, Matighara that some local goons from namely Naresh Chander singha, Ananto Burman, uttam burman, tapan burman, Maya roy along with Matighara Pradhan Mr Md. Sahid along with some local panchayat and other local goons had mobilized a JCB and were completely making illegal roads and encroachment in Our piece of land measuring 6 Bigha approx. in Rs plot 253 and 254 in Mouza Baniakhari, Opposite hotel Barasana in District Darjeeling.
