With due respect, I am producing herewith the arrested accused persons namely Biswanath Barman (45) s/o Lt. Anno Barman jof Jyotirmoy Colony, PS-New Jalpaiguri, Dist.- Jalpaiguri and the following articles under seizure:-

1. One Truck bearing registration No.-WB/73C/4693 loaded with sand.

I, SI-Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 21.02.2023 at 0045 hrs I received a secret source information that sand is being illegally mined within 200 meters of Mahananda Bridge No.- 03 at near Noukaghat . Accordingly I diarised the fact in the General Diary vide New Jalpaiguri PS GDE No.- 953 date:21.02.2023 and also informed the matter to Officer-In-Charge, New Jalpaiguri PS, Siliguri Police Commissionerate. As per kind direction and instruction of Officer-In-Charge, New Jalpaiguri PS, Siliguri Police Comissionerate myself along with force namely, VP/08 Laxman Roy, CV/116 Rohit Kumar Mahato, HG/794 Ranjit Roy, CV/306 Biswajit Roy, VP/13 Jamirul Islam, V/824 Niru Kumar Yadav all of NJP PS, SPC left for Mahananda Bridge No.- 03, near Noukaghat , PS- NJP, Dist.- Jalpaiguri at Maa Tara Ghat, Mahanandra River Bed No.- 06, PS-New Jalpaiguri, Dist.- Jalpaiguri to verify the verisity of the information. At about 0105 hrs we arrived at Maa Tara Ghat, Mahananda River Bed No.- 06, PS- New Jalpaiguri, Dist.- Jalpaiugir and being identified by the source I, held raid at Maa Tara Ghat, PS-New Jalpaiguri, Dist.- Jalpaiguri and found that One Truck bearing registration No.- WB/73C/4693 mining sand within the radius of the 200 meters of Mahananda Bridge No.- 03 . The driver of the Truck bearing registration No.-WB/73C/4693 minning sand illegayly with in 200 meters redius of the Mahanda Bridge No.- 03 violating the lease aggrement as well as violating the government order and was dangerous for Mahanda Bridge which is a public property, consequently it could damaged the bridge which is Public Property. But seeing the Police Team the driver of the truck fled away from the spot but after a hot chase, we successfully, apprehended the driver of the Truck having registration No.- WB/73C/4693 and on being asked he disclosed his name and address as noted above and on further interrogation he admit his guilt and state that he illegally mine sand within 200 meteres radius of Mahananda Bridge. That there is sufficient reason to belive that the Driver of the said vehicle have stolen sand from Mahananda River Bank within 200 meters of Radius without Legal Authority/Paper as per rules, for selling the sand cledestinely for their wrongful gain. Accordinly, I seized One Truck bearing $registration \ No. -\ WB/73C/4693\ \ loaded\ with\ sand\ after\ preparing\ proper\ seizure\ list\ and\ arrested\ the$ accused person namely Biswanath Barman (45) s/o Lt. Anno Barman jof Jyotirmoy Colony, PS-New Jalpaiguri, Dist.- Jalpaiguri after issuing proper memo of arrest and observing all the guideline issue by the aprx court. The whole process of search & Seizure was made in between 0145 hrs to 0235 hrs on 21.02.2023.
