Respected Sir,

I Richi Sharma W/o Avinash Sharma  
D/o Prem Dalmia, presently residing at Babupara  
beside lane of Krishna Kunj Bhawan P.O & PS Siliguri as  
a tenant, would like to inform you as follows:-

1) That I was married to Avinash Sharma on 1<sup>st</sup> July  
2007 at Jagdamba Uddyan, Kolkata and there are  
two children namely Vivan Sharma (14 yrs) & Devika Sharma  
(8 yrs) born out of our wedlock and during the  
subsistence of our marriage, my husband committed  
torture and violence on me and my minor children  
on numerable times publically and privately / domestically  
and consiquensly number of criminal cases are  
pending between us before the competent courts.

2) That on 8<sup>th</sup> March, 2021 my husband crossed all the  
limits when he brutally assaulted me and my children  
and somehow I was able to rescue life of mine  
and my children and since 2 years I am residing  
Richi Sharma P/1



I residing in Siliguri in the rented premises.

3) That my husband has forcefully taken away with him my minor daughter Devika Sharma (8 yrs) and since last few weeks he along with his henchmen is consistently stalking me and my son and passing vulgar comments upon me by abusing me in most filthy language, questioning my dignity as a woman by humiliating me in front of local public near my locality and I was also threatened that he will also snatch my minor son Vivan Sharma (14 yrs) from me.

4) That today at around 7 pm when my son, Vivan Sharma was going to the toilet, suddenly my husband along with his henchmen came from behind and by wrongfully confining my child they pulled/grabbed his collar and thereafter tightly hold his hairs and began to kidnap him from the spot (in front of Goshala Babupara) but after listening to the cries of my minor son, somehow with the help of local people my son was able to save his life.

Being a helpless mother, it is my humble request to you to take necessary actions in order to save my life and my son's life and liberty from the miscreants.
