Dear, sir,

I beg to inform you that I and my son live in the below mentioned residential address along with my ~~one~~ ^{two} brother in law and their familie. My husband lives and is employed in Assam.

I have been facing mental torture from my ^{one} brother in law for a very long time but since my husband does not want a family quarrel. I had been bearing the mental torture from my ^{one} brother-in-law and his wife for a very long time. They keep mentally harassing me and my son, threaten many time outside the house.

Today at 12:10 Noon, while I was going about the house with house hold duties, my brother-in-law Shri. Shyama prasad paul (mobile No. 9832332933) and his wife Smt. Antora paul (mobile 9976456459) forced them selves into my house and antora paul started slapping me and pulling my hair and shyama prasad started punching me. There after both of them started assaulting me with a wooden baton and steel rod due to which I have sustained grievous injuries to my head and hand. At last both of them grabbed my neck and started strangulating me. Due to my struggle I some how managed break free and escape and started screaming and my neighbours rushed to my house and I was able to barely escaped by getting inside my room and locking my self inside.

I fear for my life and for the life of my son. As I have been brutally assaulted with weapons and my modesty outraged and these accused person have tried to murder me. I fear the same or more serious incident will happend in the future and if these accused person are not arrested they will attempt to kill me again.

Therefore I would like to request you to treat this complaint as an F.I.R and register a case against the above mentioned accused person and arrest them as per the process of law.
