With reference to the above, this is to inform you that a supply order had been issued in favour of S.K. Enterprise (Prop.- Sri Suvankar Sil), Sishudangi, P.O. Matigara, Dist. Darjeeling vide this office letter No. 231/BCW Date: 20.02.2023 for supplying of 1040 (One thousand and forty) nos. of Lunch Packets (Good Quality Chicken Biryani / Chicken Fried Rice) for the students of Sabooj Sathai Scheme Phase-VIII on 21.02.2023 at Siliguri Boys' High School, Siliguri in connection with Public Distribution Programme at Kanchanjungha Stadium, Siliguri.

During distribution of Lunch Packets, it had been reported by few nodal teachers that some Lunch Packets were not in good quality and inappropriate for consumption. The staff of this office deployed for distribution programme examined the Lunch Packets and found the complaints genuine.

Due to gross negligence of the agency such inappropriate quality food was supplied.

Thereafter, the agency was directed to show cause vide this office memo No. 234/BCW dated 21.2.2023. He submitted his reply on 23.2.2023 which was found to be unsatisfactory and unjustified.

Hence, you are requested to treat this complaint as an F.I.R. under relevant provisions of Food Safety and Standards Act, 2006 and/or other relevant Act/Law and take necessary action in this regard.
