Respected Sir,

I, Shri. Damodar Tiwari, son of S.N.Tiwari, resident of Madhuban Apartment, Jelaparisad Road, Jyoti Nagar, Siliguri, PS – Bhaktinagar, Dist – Jalpaiguri, begs to inform you that I am the owner of a JCB being vehicle number WB – 73 – F – 8875, which I use for my business purpose and also rent out the said JCB to third party on rental and contractual basis.

That one Rasidul Haque @ Rafiqul Haque, son of Not known, resident of Chhalapak, Balapukhri, Near Bilsa Primary School, Tufanganj, Dist – Coochbehar, is a contractor who use to rent my JCB for construction purpose and I I had provide the said service on previsions occasion many time.

That on 22/02/2023 at around 12.30 PM said Rasidul Haque @ Rafiqul Haque meet me at easter Bypas near Mondal Petrol Pump where my JCB was parked and he was accompanied with Safikul Islam and Akhbar Ali who are known to him and asked me to lend him my said JCB on rental basis for construction work for 4 to 5 days at Phulbari Locality and after proper negotiation for the service said Rasidul Haque @ Rafiqul Haque paid an advance of Rs. 10,000/- to me and thereafter I directed my driver and the helper to take the said JCB to accompany said Rasidul Haque @ Rafiqul Haque with Safikul Islam and Akhbar Ali to Fulbari for their work and as such my diver along with the helper left for Phulbari at 1.30 PM on 22/02/2023.

That thereafter at around 4.30 PM my driver called me and intimated me that said Rafiqul Haque and his friends namely Safikul Islam and Akhbar Ali is asking my driver to take the JCB near the Bisk Farm Factory and I agreed to the said proposal and told my driver to do so as asked by said Rafiqul.

That at around 6.00 PM when I tried to contact my driver as well the helper of the JCB all of their mobiles phones were switched off and I was unable to contact them.

It is pertinent to mention here that I have also contact said Rafiqul Haque to confirm the condition of the JCB and my driver and helper but his mobile phone was also switched off.

Then thereafter on next day at about 7.00 PM i.e. 23/02/2023 my driver and helper returned to my residence in a very panic situation and told me that when as per the instruction of said Rasidul Haque @ Rafiqul Haque my driver took the JCB near the Biskfarm Factory then Rasidul Haque @ Rafiqul Haque and his friends Safikul Islam and Akhbar took deadly weapon and threatened him to take the vehicle to Ghoshpukur and when my driver refused he was physically abused and then after few minutes four more men with other deadly weapons namely Hakimul Islam, Basirul Islam, Saddam Hussain and Mosier, all resident of Gandagach Das para, Chopra, Dist - Uttar Dinajpur entered into the JCB and hijacked the said JCB with the driver and the helper and took away their phone and money and other belongings.

That thereafter my JCB along with my driver and helper were forcibly taken to Goshpokur and then any how my driver and helper escaped and rescued themselves and somehow reached at my place and informed me about the incident. Then when I called said Rasidul Haque @ Rafiqul Haque then he told me that they will return my JCB if I pay them Rs. 10,00,000/- by within 24 hours.

That I am constancy receiving threat calls from various numbers and they are threatening me that if I donot pay the said money then I will not be able to find out my JCB.

Sir, I am a law abiding citizen of this nation and I am under constant fear for the loss and damage of my property and I will be highly obliged if you take proper steps against the said persons and do the needful.
