Sir,

I would like to draw your kind attention towards a theft that has taken place within the last few days and was detected by one of our staff members on 22nd February 2023 in the O/ of the President, D.C.D.R.C., Siliguri under Consumer Affairs Department, Govt. of West Bengal. It has come to our attention that the copper wires, connecting the indoor and outdoor fittings of A.C. Units have been stolen, making the units inactive and unable to function. The approx. The cost of the copper wires is estimated at Rs. 16,000/- (Rupees sixteen thousand).

Therefore, I would like to request your good self to look into the matter and take necessary action.
