

I, Karma Ishering Lama, son of Karma Lama resident of Salugara would like to state that today on 25/02/23 at around 5:30pm to 6pm, while travelling from Bengdubi to back home Salugara, there were 3 to 4 bikes/scooty performing stunts and driving rash on Bengdubi Military Station road in front of my car, without following any traffic rules. All of a sudden, a scooty overtook my car and stopped right in front of my car and I had to apply emergency break. Then after the two men came to my car and started abusing and assaulted me without any reason/fault of mine. My wife and my 4 yes old daughter was in the front passenger seat and they were misbehaving with them as well. I tried to calm them down but they were totally drunk and started hitting me and damaging my car. So my defense I and my wife came out of the car but they assaulted/kicked my wife as well. Till that time 8-10 men had arrived on their bikes and started hitting me and damaging my car. I had no other option but to escape from the situation to save me and my family but they started following my car on their bikes and they were all carrying weapons such as knives and sticks/rolls. I somehow escaped the situation but due to traffic near Bagdogra after Bihar More, I had to stop and that is when they attack

me ~~said~~, my vehicle and my family sharp knives. They tried to forcefully open door and attack me with the knives. In an attempt they punctured my rear right tyre with the knife and broke my car handle and damaged the car. But still with the punctured tyre I somehow managed to reach Matigara Balesun bridge where there were two policemen so I tried to stop and ask for help. However, they could not control the men as they were 8-10 men chasing me. I again drove my car towards Dajeeling More and I stopped my car at City Centre outpost where there were policemen who took control of the situation. However the men were misbehaving with us at the outpost in front of the policemen also. Out of 8-10 men I have recognized three persons who are ① Abhijeet Singha - age 21, son of Nirmal Singha, resident of Tumba, Jote Matigara, ② Subha Das, age 28, s/o Deep Charan Das resident of Ramkrishna Para, Matigara ③ Subho Roy, age 21, s/o Jagan Roy, resident of Matigara.


All the accused assaulted me and my wife ^{with an attempt to kill us} and outrage her modesty and my 4 year old child was also mishandled by the accused and she is in pain and in a state of shock to witness her father beaten up by the accused.

They made a video of my car and took my car details and threatened me and my family

that if I register my case against them to the police then they will harm me and my family any where in Diliqun. They didnot show any sign of remorse and disrespected ~~to~~ my family and friends.

They seem to have utter disregard against the law and order and acted like hoodlums trying to attack me and my family with knives. Hence, I would like to register an FIR against the accused persons ~~with~~ to take appropriate legal action against them.
