I s/o Sant Tandra Ghosh w/o Sri Dilip Kr. Ghosh s/o Mrityunjay Ghosh w/o Medical more Sannyashi More PO Sukhantaganar Po Matigara Dist Dargjeeling, would like to inform you that as follows:

- 1) That Sri Dilip Kr. Ghosh s/o Late Ghabinda Ch. Ghosh is my legally married husband, our marriage was solemnised as per Hindu rites and customs on 12-12-1990 at my father's house at Nadea Korimpur, West Bengal marriage
- 2) That after our marriage we started to live as husband and wife at the house of my husband at Nadea, Duxlavpur, W Bengal and out of our wed-lock relation two male baby was born.
- 3) That soon after marriage my husband started to misbehave with me he can't tolerate me and without any reason, he scold me by filthy, stang and offensive language, which is increased day by day, during the period of last 10 years, I anyhow I have been passing my days with my child with a hope if the such ^{my} nature character be changed in future but in vain.
- 4) That now I have been living with my family member permanently at Medical more, Under the Jurisdiction of Matigara Police Station Dist Dargjeeling. My husband use Alcohol and Drugs each and every day. On drunken condition he touch me physically and mentally and also use to abuse toward me by stang, filthy languages. In the presence of my tenants and local people, I informed his such criminal Act and Activities to the C.O of his office, but no fruitful result and also informed to human rights at Delhi.
- 5) That on 24-2-2023 at about 11 P.M. at night I told/asked my husband, "why you used Alcohol excessively, then he became furious and started to assault me by bamboo stick and fist and blows on my person in the presence of my tenants as a result I receive several severe injuries on my head and person, he also assaulted me by holding my hair long and ~~and~~ kicked my abdomen then I became ill and I brought in the hospital (Disan) with the help of my local sister. Now I am under treatment. My husband threatened me with dire consequences that if I disclose his aforesaid criminal Act and Activities to the police, in that case he i.e my husband set fire on my person by pouring Kerosene oil.
