I, **Niladry Bardhan**, Son of Late Pradip Bardhan, resident of Netaji Subhash Road, Ward No. 20, Subhash Pally, District- Darjeeling, Pincode- 734001, do hereby like to inform you that, **Miss Simran Tamang, Miss Priya Sah & Miss Pragya** are staying on rent in my colony at Subhaspally area, near Netaji Boys' High School, they all are bachelor and many other boys and girls use to come their home and stay late night doing party, alcohol, loud music and also involved in antisocial activities. They sometimes get into bad fight with each other which disturbs the pleasant and harmony of the entire colony. This is the everyday scenario at present. Yesterday one **Celina Rai** (who claimed to be friend of the three above mentioned girls) and her boy friend **Sisir Subba** along with his male friend came to visit their place, where they probably get drunk and partied till late night. I was just passed by that time towards my house and saw them fighting with each other fully drunk using abusive language in a loud tone to each other. Being a responsible citizen, I stopped and tried to stop them doing so in the middle of the road, because its affects the peaceful environment of the society. So, it's my request to you to take necessary actions against the wrongdoer who beat me like this and also do something with the illegal activities they are committing in the rented place which disturbs the harmony of the entire society.


