One Sanjay Dutta, (Mobile No - 9382078751 / 6296913179) Son of Notan Dutta, resident of Pubdibari, Dakshin, Kalarayerkuthi , Post Office & Police Station -Pundibari, District - Coochbehar, PIN - 736165, at present residing South Shanti Nagar, near Durgamandir, Housing complex, Siliguri. was introduced to me through Facebook on October 2020, Then we met face to face in the month of January 2021and we start love each other many times Sanjoy used to came to the bar to meet me, One day he suddenly told me that he wanted to marry me. When he said that, I told him that I have to talk to my guardians about it. If they agree, we would get married. He then told me that it was his responsibility to persuade my guardians. He then told me that if we registered our marriage, it would be easier for my guardians to accept this marriage. He took some pictures of our intimate moments without my knowledge. Since then he had been constantly pressuring me, saying that if I did not register marriage with him, he will viralize our intimate moments on Facebook. Then I went to Coochbehar on 2 August 2021 to register my marriage in order to save my and my family's honour. After registering I went to his house and after 2 days we had a reception party. After 7 days in Coachbehar we returned to Siliguri and started living as husband wife in a rented house (House Owner Name - Spandan Roy Chowdhury ,Mobile No- 9832733335) situated at Swamiji More, Ward No-15, Post Office-Rabindra Sarani, Police Station - Siliguri, District- Darjeeling

Someday everything was fine After some time he started torturing me and demand money to my parents. After that he always threatened me and torture me brutally and always says that if my family member not give her 10 lakhs then he will leave me, Not only that, he beat and abused me in bad language and said that if my family can't pay Rs. 10 (ten) lakhs then all the pictures of our intimate moments will go viral on Facebook. I told them that my family could not afford it. Then he beat me in front of his mother and his mother did not try to save me from him, then I asked to my parents and they pay her 4.5 lakhs. At the time of marrage my father give me one gold chain 20gm 2pair of jhumka 32gm and one pair of bangles 50gm as my streedhan arrival, but he took all my ornament on my almira without my concent. Day after day his torture went out, All my family members live in Delhi so I tolerate everything I am helpless and I don't know anyone in Siliguri.

I saw a post on Sanjay's Facebook page on 25 january It shows a picture of Marrage with a girl, I did not understand anything and called Sanjay and said that he really married a girl.

1st february Sanjay came to our house and beat me brutally and threw me out of the house, I was admitted to the hospital for 2 days, I am mentally broken and suffering from anxiety, now I am at a friend's house.

It is, therefore, prayed considering the facts and circumstances mentioned above you will be pleased to take necessary steps to save me from their hands and also save my family refraining them from doing any harm to the dignity of my family.
