## Subject: F.I.R.

I, Koushik Paul, Son of Nitai Paul, Resident of 12, Bimal Sinha Sarani, Hakimpara, Post Office & Police Station: Siliguri, Within S.M.C. Ward No. 12, Siliguri, District: Darjeeling, Pin Code: 734001 would like to inform you that:

- 1. My marriage was solemnized on 15-01-2021 with Ankita Kundu, Daughter of Avijit Kundu, Resident of 2<sup>nd</sup> by Iane, Swamiji Sarani, Hakimpara, Within S.M.C. Ward No.15, Siliguri, District: Darjeeling, Pin Code: 734001 according to the provisions of Special Marriage Act, subsequently on 19-01-2021 our marriage had been solemnized as per the Hindu rites and customs.
- 2. That after our marriage, me and my wife started our nuptial life at 12, Bimal Sinha Sarani, Hakimpara, Post Office & Police Station: Siliguri, Within S.M.C. Ward No.- 12, Siliguri, District: Darjeeling, Pin code – 734001. In between for few months we had stayed in Trivandrum, Kerala for my professional life. It is pertinent to mention here that I have a Partial Nephrectomy operation and Appendix operation on 20-09-2022 from Manipal hospital, Bangalore and we came back to Siliguri after the operation on 30-09-2022. Post 30-09-2022, my wife started fighting for every small reasons and always told me she wanted to file a divorce because of my Health condition. Then one fine day she called her parents giving false accusations on me and her father came home and hit me even knowing about my health condition. Then they took her daughter from our house with all her belongings. Post which her relatives named by, Arjit Dutta Joardar and his wife, Soma Routh (Dutta Joardar), Resident of Raja Ram Mohan Roy Road, 2<sup>nd</sup> by lane, Hakimpara, Post office and Police station: Siliguri, Pin code-734001, pressurized me and my family to agree for a mutual divorce, I and my family still tried to contact my wife and bring her back to continue our relation on a good note. But she always denied telling me that as my health condition is not good, so she doesn't want to continue any relation with me. Coming under their pressure as referred above, we agreed for a mutual divorce. It is not out of place to mention here that one mutual agreement and petition for mutual divorce has also been prepared for the same by their family. But the same has not been executed up till now.
- 3. Today i.e., on 26-02-2023 as per our Mutual Consent my wife's family members Atisha Kundu, Avijit Kundu, Arjit Dutta Joardar, Soma Dutta Joardar along with some other people came to our house to take all the belongings of my wife and to return our

ngings and at that time, they started insulting my parents by using abusive languages indicating my parents and when I raised objection, at that point of time the said Arjit Dutta Joardar and Avijit Kundu and the other persons who came with them started hitting me and my parents. Every other people in our house were present at that time and tried to bring the situation under control. Soma Routh(Dutta Joardar) started using abusive languages to everyone present and threatened me by saying that they will lodge false and fabricated F.I.R. against me and my family members only to harass us. I am still under Medical Treatment and knowing fully aware of my health condition they started hitting me in the same area of my operation and for that reason I am completely feeling unwell and the entire incident happened infront of Munna Mondal and Pampa Saha along with family members in my house. They also tried to restrain them, but all efforts are in vein.

I have made several requests to my in-laws as referred above for mediating this matter but they did not care a straw and kept me torturing physically and mentally, they are continuously threatening me for dire consequences. Naturally, feeling myself as well as my family in a helpless condition, I am lodging a F.I.R. against the people as requesting to take appropriate steps in this regard below:
