In producing herewith one accused person namely (1) Deepraj Singh (M/26yrs) S/O-Lt Acchalal Singh of Upper Bhanu nagar, Near Saw Mill, W.No- 43, P.S- Bhaktinagar, Dist-Jalpaiguri (not verified) in custody and the following property under seizure along with seizure list:-

30(thirty) pieces of vials of LUPIGESIC Injection composition with Buprenorphine Hydrochloride 1P equivalent to Buprenorphine 0.3 mg each vials containing 02 i. ML (Total 60Ml) and Marked as exhibit-"A"

30(thirty) pieces of vials of PHENERGAN Injection which composition with hydrochloride 1P 25mg each vials containing 02 ML (total 60Ml). and Marked as ii.

exhibit-"B"

30(thirty) pieces of vials of DIAZEPAM Injection composition with Diazepam 1P 5mg each vials containing 02 ML(total 60Ml) and Marked as exhibit-"c" iii.

One NYLON BAG Multi colour. iv.

I, SI Rantu Haldar S/O- Monoranjan Haldar of Bhaktinagar PS/ SPC do here by lodged this complaint to the effect that on 26.02.2023 at 19.05hrs received a secret source information that one person having possession of huge quantity of Narcotics Substances in his possession without valid documents and standing at Roy colony more near kali mandir to sell the same to his designed customer for his wrong full gain. Accordingly the information was diarized vide BKN PS/SPC GDE No. 1468 Dtd. 26.02.2023 and informed with a written letter to the I/C Bhaktinagar PS/SPC about this information. As per kind order of I/C Bhaktinagar PS/SPC myself along with, SI Sajal Roy, SI Prosenjit Dey Sarkar, ASI Dipak Karmakar C/1431 Dilip Barman. C/915 Chandra Prakash Adhikary CV/614 Sumit Kr Roy CV/014 Labanyamay Barman all of Bhaktinagar PS/SPC left by govt. vehicle vide BKN PS/SPC M.C.C No-399/23 Dt. 26.02.2023 to verify the veracity of information corresponding BKN PS/SPC, GDE.NO. 1469 Dated. 26.02.2023. At the time of departure from Bhaktinagar PS I bring digital weighing machine, envelope, white paper, sealing wax, gum, seal etc. At about 19.35 hrs on arrival there I called two disinterested witnesses from the spot who were present & available there at that time namely (i) Silip Roy (42) S/O-Sachin Roy of Pradhanpara, W.No-42, P.O- Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri M-9641392191 and (ii)Debendar Thakur (32) S/O- Prakash Thakur of Pradhanpara, W.No-42, P.O- Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri M-7031268165 also disclosed the matter regarding our information. I also requested them by issuing a written letter for their Consent to accompany us in the whole process during search and seizure if necessary, and obtain necessary permission of their presence as witnesses in the entire process of Search and Seizure under relevant provision of law as witness. At about 19.45 hrs as per identification by source I managed to detain the said person. After disclosing our identity, we detained one person with strong reason to believe that he is illegally carrying Narcotics Substances for supplying/ selling the same in Siliguri area for his wrongful gain. On being asked he disclosed his identity as noted above and admitted that he possessed Narcotics Substances. Then I asked him whether he wanted to be search in presence of an Executive Magistrate or any Gazetted Officer and he agreed to search by any one. I served them a notice in accordance with provisions of law in this regards. I also offered the independent

and apprenenced person to search our Police Party as per provision. But they refused to search by the police party. Then I asked ASI Dipak Karmakar with a requisition to go to Shri Shantunu Tarafdar ACP AP/SPC office as he was detailed for Special Executive Magistrate. After an hour at 20.50 hrs ASI Dipak Karmakar returned with Special Executive Magistrate Shri Shantunu Tarafdar ACP AP/SPC. I disclosed the identity of Shree Shri Shantunu Tarafdar ACP AP/SPC to the apprehended person and witnesses as a Special executive magistrate. Thereafter under the supervision Shree Shri Shantunu Tarafdar ACP AP/SPC and in presence of him and independent witnesses I conducted search of the above apprehended person keeping strict, regard and found the articles as per seizure list in a multi colour nylon bag from his possession. On being asked he further confessed in presence of Special executive magistrate and other witnesses that he procured the Narcotics Substances clandestinely for the purpose of selling to his designed Customers in order to earn huge amount of money for their wrongful gain. On interrogation he disclosed that he has been dealing in such illegal drug trafficking business and selling the same to the adjacent area of Siliguri, NJP and Bhaktinagar area. On examination of the alleged apprehended person noted above regarding any documents for carrying/possessing of said Narcotics Substances he failed to produce any documents or license in support of possessing of such drugs. Then as per direction of Shree Shri Shantunu Tarafdar ACP AP/SPC I seized the articles under proper seizure list and Label under the supervision of Shree Shri Shantunu Tarafdar ACP AP/SPC in presence of witnesses duly signed by them as well as the accused persons and marked the seized exhibits as noted above.

The seizure and label was made between 21.05 hrs to 21.45 hrs. The whole process of search and seizure was video graphed. Then I arrested the above noted accused person u/s- 41 Cr.P.C after observing all formalities of arrest and disclosed him cause of arrest issuing necessary Memo of Arrest. The copy of seizure list and Memo of Arrest was supplied to above noted alleged person under proper receipt as the alleged accused person violated the terms and condition of N.D.P.S Act possessing Narcotics Substances without any lawful documents.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person namely 1. Deepraj Singh (M/26yrs) S/O- Lt Acchalal Singh of Upper Bhanu nagar, Near Saw Mill, W.No- 43, P.S- Bhaktinagar, Dist- Jalpaiguri (not verified) and arrange for its investigation.
