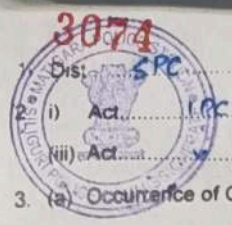

I Smt Rina Rai W/O Lt Ram Babu Rai R/O Ujanushib Nagar Ward No:46 P.O Pradhannagar P.S Matigara Dist: Darjeeling Would Like To Lodge This Complaint In Your P.S Againt My Sons Father In Law Namely Naresh Rai S/O Not Known R/O Gurung Busty Lohapally P.S Pradhannagar And His Other Relatives Mamely Anu Rai D/O Naresh Rai , Nilu Rai D/O Naresh Rai, Rajiv Rai S/O Not Known, Bishnu Rai S/O Not Known All Are The Resident Of Same Address And Kanahiya Rai S/O Radheshyam Rai R/O Thokkar Near Joda Pul Khatal P.S Matigara, Krishna Rai S/O Do, Nithelesh Rai S/O Do, Kalu Rai S/O Do All Are The Resident Of Thokkar Near Jodapul Khatal P.S Matigara that the above mentioned Anu Rai is the wife of my son namely Deepak Rai s/o Lt Rambabu Rai it is important to mention here that Anu Rai Along with all of her above mentioned family members were creating pressure and coercion on me and my son for the transfer of the name of my land which is situated in the above mentioned address in her favour for her malafide intentions and unlawful gains since long time and we always declined the same all the time but yesterday that is 22/02/2023 at around 22:00 hrs the above mentioned persons came to my house who were instigated by her and started Assaulting me and my family members brutally with all there might and also tried to strangulate me and my daughter namely Radha Rai it is very crucial to mention here that the above mentioned Kanahiya Rai, Krishna Rai, Nithlesh Rai, kalu Rai, not only brutally slapped punched and kicked me and my daughter but also tear apart my saree and blouse which I was wearing at that time and they also broke my led television and took away cash amounting 10,000 Rupees which was there in my almira and they were complete motive and intention of killing me and as a reason of there such assault I was not able to lodge the F.I.R on time in your P.s and hence finding no way out and there clear threat and indication of killing me I am lodging this complain in your P.s with a view that proper necessary action is taken against them.


