With due respect and humble submission, in producing herewith one accused namely Lalu Kamti (32) S/O Bhiko Kamti of Coolipara, Dharamnagar, P.S-Pradhannagar, Dist. Darjeeling under arrest along with following articles under proper seizure ;

- i) 12 (Twelve) bottles of Himalayan Gold 60 up, India made liquor, each bottle containing 600 ML, each MRP 155/- (Total 7.200 Ltrs)

I ASI Tarun Kanti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 28.02.23, I was engaged mobile van duty vide Pradhannagar PS GDE No. 1572 dtd. 28.02.2023 along with CV/223 Swapan Chettri and CV645 Pankaj Gupta during evening mobile duty at 18.15 hrs. I received an information one person namely Lalu Kamti storage huge quantity of illegal liquor at Coolipara and selling the same. Accordingly I informed to you and as per your direction myself along with force held raid and found that he is selling the liquor openly, then I detained the above noted person and on being search recovered above noted articles, On demand he failed to produce any valid document in respect of recovered articles. On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 18.45 hrs to 19.15 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Lalu Kamti (32) S/O Bhiko Kamti of Coolipara, Dharamnagar, P.S-Pradhannagar, Dist. Darjeeling and arrange for its investigation.
