Sub: Request for investigating on the death of Mr. Tenzing Chendup Kurbahpa

Sir/ Madam,

I the undersigned s/o Mr Tenzing Chendup Kurbahpa resident of Pani House, Gangtok request you to kindly investigate the death and the circumstances surrounding the death of my husband who passed away on 22nd February 2023 at Blue Mountain Resort Siliguri where they run an illegal poker place named Country Poker Place.

The place is run by one person Dasha or Tashi (from Bhutan) along with Rahul Gupta and some other partners. On 22nd February 23 I came to know that my husband is at that place playing poker on the invitation from Dasha/Tashi. The details can be recovered from his call or message records. Following which I called up Dasha but he did not answer the call after which I spoke to Rahul Gupta and told him that my husband is not well ~~and~~ ^{he informed me} that Tenzing is there at that place and played poker on credit given by Dasha and lost 35 lakhs rupees. I clearly told him that we are not in a position to pay the money and that the invitation sum by them is illegal and if any untoward incident occur then he & Rahul & Dasha will be responsible. Mr Tenzing suffers from depression.

Received on 03/03/23 at 13:55 hrs. vide PDM PS GD Entry no. 139 date 03/03/23 and started PDM PS case no. 140/23 date 03/03/2023 u/s 306 I.P.C. and endorsed to SI, Kalyan Saha for investigation.

My husband was due to return that very day he had informed his wife at 11:30 am in the morning. I spoke to Rahul around 8-7 pm in the evening. But the same night at 2 am when I called my husband a police personal assured his phone and informed that he was found dead in his hotel room. I request you to kindly look into the matter as I strongly believe that after the phone call to Rahul Gupta they must have pursued their regarding the money which led abetted to Tenzing committing such act. Also Rahul Gupta had my phone call no. via which he could have informed me but neither did he inform me nor is he taking calls since that day.

Once again I earnestly request you to look into this matter as it led to my husband to commit such an act, the hotels in which such thing operates as well as the people running such establishment are responsible and abetted to my husband. These places if not monitored, closed or investigated will end up claiming many more lives. (The phone no of the people using the poker/golace is also given below).
