With due respect and humble submission, in producing herewith one accused namely Raj Kishore Thakur (34 years) s/O Kirani Thakur of Dhum Nagar, Pachari Tola, P.S- Nautan, Dist. Bathia, Bihar under arrest along with following articles under proper seizure ;

- i) 17(Seventeen) Plastic bottles of "KD 50 Whiskey" Blended, bottle & marketed by SAARAN INDUSTRIES Kamarkuchi, Sonapur, Kamrup, **Assam**, each containing 750 Ml, each MRP 120/-
- ii) 24(Twenty) Plastic bottles of "KD 50 Whiskey" Blended, bottle & marketed by SAARAN INDUSTRIES Kamarkuchi, Sonapur, Kamrup, **Assam**, each containing 375 Ml, each MRP 60/-
- iii) 47(Forty-Seven) Glass bottles of "Mc Dowells No.1 Luxury" MFD By Spey bottlers Pvt. Ltd, Azara, **Assam**, each containing 180 Ml, each MRP 85/-
- iv) One Light Brown Colour Trolley four wheelers bag, written

I SI Abhishek Theengh presently posted at Pradhan Nagar Police Station, Siliguri Police Commissionerate would like to lodge this written complaint against above noted accused person to the effect that today on 03.03.2023 in course Spl Mobile Van duty at PS area with force C/762 Mojibul Rahaman, CV / 992 Jagadish Biswas, CV/646 Baban Das, CV/242 Rakesh Mongar vide PDN PS GDE NO 150 dtd.03.03.2023. During Mobile duty at 19.35 hrs, I received an information that the one person suspiciously moving at Siliguri Junction area near Mount Blue Tour & Travels under Pradhan Nagar PS with a trolley band. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and as pointed by the source we apprehended the above noted person and search trolley bag recovered above noted articles, On demand apprehended person failed to produce any valid document in respect of recovered articles. On interrogation he admitted that he carrying the liquor from Assam illegally without obtaining valid document for sell the same in Bihar in high price for his illegal gain. Accordingly, I seized & label the above noted articles in between 20.05 hrs to 20.55 hrs and I arrested him.

Therefore, I request you to kindly register a specific case under proper section of law against the arrested person namely Shiv Kumar Ray (32) S/O Sri Bhajan Ray of Jagadish Pur, P.O- Bhadiyan P.S-Nanpur, Dist. Sitamari, Bihar and arrange for its investigation.
