With due respect and humble submission, in producing herewith one accused namely Dayal Das (28years) S/O Mohanta Das of Simulguri, Kalicharan Basti, P.s-Bhaktinagar, Dist. Jalpaiguri under arrest along with following articles under proper seizure ;

- i) 20(Twenty) bottles of 60 up Himalayan Gold Country spirit , each bottle containing 600 ML, each MRP 155/- .

I ASI Manoj Kr Roy of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 04.03.23 at 16.05 hrs received a source information that one person is selling the liquor openly Infront of Heritage Hotel, Hill cart road under Pradhannagar P.S. Accordingly I diarized the matter vide Pradhannagar P.s GDE no. 220 at 16.05 hrs dtd.04.03.2023 . I also informed to you and as per your direction myself along with force CV/223 Swapan Chettri and CV/645 Pankaj Gupta all of Pradhannagar P.S.left from PS Vide Pradhannagar PS GDE No.221 at 16.10 hrs dtd.04.03.2023 .After reach near heritage hotel I found that one person openly shelling the liquor ,then I detained the said person and on introgation he disclosed his identity noted above. Then I search his bag and recovered above noted articles. On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 17.50 hrs to 18.20 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Dayal Das (28years) s/O Mohanta Das of Simulguri, Kalicharan Basti ,P.s-Bhaktinagar, Dist. Jalpaiguri and arrange for its investigation.
