Sir,

In producing herewith one arrested accused person namely Dhiren Roy (M-58) S/O Lt Naren Roy of Kawakhali (Near Bazar), PO Sushruta Nagar, Dist Darjeeling along with seized articles (i) 16 Sixteen Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 155/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL N-) 01

I, SI Ganesh Ray of North Bengal Medical College & Hospital OP under Matigara PS SPC do hereby lodge a written complaint against the above noted accused person to the effect that today on 04/03/2023 at 19:05 hrs during evening RT mobile duty vide MCC No- 344/23 dated 04/03/23 I received secret source information that, one person is stocked huge quantity of country spirit at his house situated at Kawakhali. Accordingly I informed the information to OC NBMC&H OP over telephone and as per his direction I along with C/1071 Sumit Sherpa and C/1085 Mithun Debnath and left for PO to workout the information. On arrival at Kawakhali at 19:25 hrs being pointed out by the source, we conducted raid in the house of Dhiren Roy S/O-Lt Naren Roy of Kawakhali (Near Bazar), PO Sushruta Nagar, Dist Darjeeling and recovered total 16 Sixteen Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 155/- each bottles. On demand he failed to produce any valid documents/license in support of the same and stated that he will sale the same to the local public of Kawakhali and adjacent area illegally with a view to earn huge money for his lively hood. On interrogation he disclosed his name and address as Dhiren Roy (M-58) S/O-Lt Naren Roy of Kawakhali (Near Bazar), PO Sushruta Nagar, PS Matigara, Darjeeling. Accordingly I seized 16 Sixteen Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 155/- each under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 19:35 hrs to 19:50 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 2480/-

Under the above circumstances I am submitting this written complaint against the above accused person namely Dhiren Roy S/O-Lt Naren Roy of Kawakhali (Near Bazar), PO Sushruta Nagar, Dist Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
