Sir,

With due respect and humble submission, in producing herewith one accused namely Musha Mandal (33) S/O- Lt Mijanur Mandal of Lichubagan, Barakote W/No- 18 PS- Siiliguri Dist- Darjeeling under arrest along with following articles under proper seizure-

- i) 10 (Ten) Sealed Plastic bottles of Himalayan Gold, Country Spirit, 60\* up each bottle containing 600 ML each bottle MRP RS- 120 total amounting RS- 1200/- (120X10= 1200).

I ASI Debasish Das of Siliguri PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 05.03.23 I was performing Morning Special mobile Van duty vide Siliguri PS GDE No- 255 Dated- 05.03.23 along with others officer and force. During mobile van duty at 08:45 hrs I received a source information that one Narayan Sarkar was storing and selling liquor illegally in his Hotel at Lichu Bagan Bagrakoate. Accordingly I share the information with you and as per your kind order myself along with others officer and force, held raid in the Hotel identify by source and we apprehended the above noted person and on search recovered above noted articles, from the hotel of Musha Mandal at Lichu Bagan Bagrakoate On being asked he stated that he used to sale the 60 up country Spirit to locality without any valid documents as Musha Mandal violated the norms of Bengal Excise Act for selling the said Liquor without any valid License. On demand he failed to produce any valid document in respect of recovered articles. Accordingly, I seized & label the above noted articles in between 09:15 hrs to 09:35 hrs and I arrested him in presence of available witness duly signed by them.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Musha Mandal (33) S/O- Lt Mijanur Mandal of Lichubagan, Barakote W/No- 18 PS- Siiliguri Dist- Darjeeling, arrange for its proper investigation.
