With due respect, I am producing herewith the arrested accused persons namely (i) Biru Barman (24) s/o Lt. Gouranga Barman of Netaji Nagar, Ward No.- 42, PS- Bhaktinagar, Dist.- Jalpaiguri (ii) Bishnu Barman (23) s/o Lt. Subhash Barman of Biveknanda Nagar, Ward No.- 42, PS-Bhaktinagar, Dist.- Jalpaiguri (iii) Sajjat Hussian (23) s/o Jakir Hussian of Jumagach, PS_ Rajganj, Dist.- Jalpaiguri (iv) Subhankar Sarkar (23) s/o Uttam Sarkar of Bhawesh More, PS- New Jalpaiguri, Dist.- Jalpaiguri and the following articles under seizure :-

- I. One Iron made Hasua and one Iron made sabol, & One blunt Iron Rod from the possession of accused Biru Barman (24) s/o Lt. Gouranga Barman of Netaji Nagar, Ward No.- 42, PS- Bhaktinagar, Dist.- Jalpaiguri.
- II. One sharp cutting knife and one plastic made charger torch light and Iron Road from the possession of accused Bishnu Barman (23) s/o Lt. Subhash Barman of Biveknanda Nagar, Ward No.- 42, PS-Bhaktinagar, Dist.- Jalpaiguri.
- III. One Iron made Hasua, Screw Driver & One Blunt Iron Rod from the possession of Sajjat Hussian (23) s/o Jakir Hussian of Jumagach, PS_ Rajganj, Dist.- Jalpaiguri
- IV. One Iron made Bhojali and one sharp cutting knife, One Torch Ligh, one Blunt Iron Road from the possession of accused Subhankar Sarkar (23) s/o Uttam Sarkar of Bhawesh More, PS- New Jalpaiguri, Dist.- Jalpaiguri

I, SI-Pradeep Diyali of NJP PS, Siliguri Police Commissionerate beg to state that on 22.02.2023 at 0045 hrs I received a secret source information that a gang of miscreants come to Gora More with deadly weapons and assembled there and making preparation for committing dacoity at Gora More, Thakur Nagar area Accordingly, I informed the fact to you and diarized the fact in General diary vide NJP PS GDE No 1006 dated 22.02.2023. As per kind order myself along with VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy CV/824 Niru Kumar Yadav all are of New Jalpaiguri PS, Siliguri Police Commissionerate left for Gora More, PS-New Jalpaiguri, Dist.- Jalpaiguri to work out the information in hand. I also informed the fact to night RT Van officer ASI Dhurba Kumar Mishra of New Jalpaiguri PS, Siliguri Police Commisisonerate along with force and directed him to come to Gora More to accompany with us. At about 0115 hrs on 22.02.2023 we arrived at Gora More, PS-New Jalpaiguri PS, Siliguri Police Commissionerate. After a while ASI Dhurba Kumar Mishra along with force came to Gora More and accompany with us. At about 0155 hrs we found that 10/11 persons assembled in a dark place at Gora near Petrol Pump, under New Jalpaiguri PS, Dist.- Jalpaiguri and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 04 (Four) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above and also disclosed that they assembled there to commit dacoity at Gora More & Thakurnagar area.
