Sir,

With due respect, I am producing herewith one arrested accused person namely Dipen Biswas (40) S/O Shankar Biswas of Bhaktinagar, PS- New Jalpaiguri, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 13 (Thirteen) bottles of Himalayan Gold Country Spirit 60 UP country Spirit (each bottle containing 600 ml.)
2. 03 (Three) Bottle of Himalayan 70 UP Fata Fati Country spirit (Each Bottle Containing 300 ml) in each bottle.

I, SI-Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 27.02.2023 at 19.15 hrs I received a secret source information that one person namely Dipen Biswas (40) S/O Shankar Biswas of Bhaktinagar, PS- New Jalpaiguri, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at Bhaktinagar Bazar area under NJP P.S. Accordingly, I diarized the fact in he General diary vide NJP PS GDE No: 1292 date: 27.02.2023 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 Laxman Roy, HG/794 Ranjit Roy all of NJP PS, SPC left for NJP Bhaktinagar Bazar area, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 19.45 hrs we arrived at Bhaktinagar Bazar area, and being identified by the source I held raid the shop where the above noted accused person selling ID Liquor. Accordingly as per the indication of Source I managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 20.05 hrs to 20.45 hrs on 27.02.2023.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Dipen Biswas (40) S/O Shankar Biswas of Bhaktinagar, PS- New Jalpaiguri, Dist.- Jalpaiguri and arrange for its investigation.
