With due respect, I am producing herewith one arrested accused person Surojit Roy (32) S/O Lt. Suren Roy of Alipurduar Junction, Kalibari Colony, P.S- Alipurduar, Dist.- Alipurduar, A/P South Colony Bazar, P.S- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 15 (Fifteen) bottles of Himalayan Gold Country Spirit 60 UP country Spirit (each bottle containing 600 ml.)

I, ASI-Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 27.02.2023 at 19.15 hrs I received a secret source information that one person namely Surojit Roy (32) S/O Lt. Suren Roy of Alipurduar Junction, Kalibari Colony, P.S- Alipurduar, Dist.- Alipurduar, A/P South Colony Bazar, P.S- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his hotel at NJP Hotel Line area. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 1292 date: 27.02.2023 and informed the fact to you. As per your kind direction and instruction myself along with VP/13 Jamirul Islam, CV/306 Biswajit Roy, CV/116 Rohit Kr. Mahato all of NJP PS, SPC left for Canal Road, Fulbari, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 19.55 hrs we arrived at Canal Road, and being identified by the source I held raid the hotel where the above noted accused person selling ID Liquor. Accordingly as per the indication of Source I managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is the staff of this hotel namely Dinesh Hotel and he is selling ID liquor at his hotel since long for his illegal gain. On search the above noted I/D liquor recovered from his hotel. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his hotel. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 20.25 hrs to 20.55 hrs on 27.02.2023.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Surojit Roy (32) S/O Lt. Suren Roy of Alipurduar Junction, Kalibari Colony, P.S- Alipurduar, Dist.- Alipurduar, A/P South Colony Bazar, P.S- NJP, Dist.- Jalpaiguri and arrange for its investigation.
