Harnarayan Barman of Post Office Galli, Bhaktinagar, ward No.- 35, PS- New Jalpaiguri, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at IOC Road, under NJP P.S. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 1346 date: 28.02.2023 and informed the fact to you. As per your kind direction and instruction myself along with VP/13 Jamirul Islam, CV/824 Niru Kumar Yadav, CV/306 Biswajit Roy all of NJP PS, SPC left for IOC road, PS- NJP, Dist- Jalpalguri to work out the information in hand. At about 1755 hrs we arrived at IOC Road, under New Jalpaiguri PS, Dist.- Jalpaiguri and being identified by the source I held raid the shop where the above noted accused person selling ID Liquior .
