namely Sudip Mukherjee is an employee and Manager of Bangiya Vikash Gramin Bank  
and at presently he is posted at Patiram Branch at Vill & P.O - Patiram, Pin-733133, ,  
District- Dakshin Dinajpur, West Bengal and my daughter-in-law also employed in the
