In producing herewith the arrested person namely Laxman Singh (20/M) S/O Kapil Singh of Jyotinagar, Charak Math, Ward No. 04, PS- Siliguri, Dist- Darjeeling along with seized articles viz :- along with seized articles viz :- (I) 12 (Twelve) Bottles of Himalayan Gold Country Spirit each bottle containing 600 ml. and marked as "Exhibit-A" (II) 01(one) Bottle of Himalayan Gold Country Spirit containing 600ml. taken out as sample from "Exhibit-B" for examination and marked as "Exhibit-A-I (Grand total 12X 600 ml.= 7.2 Ltrs.),



I ASI- Raju Sarkar of Khalpara TOP under PS Siliguri, Siliguri Police Commissionerate would like to lodged this written complaint against the above noted person to the effect that on 05.03.2023 while I performing K-27 Mobile van duty vide Khalpara PS GDE No.112 Dt.-05.03.2023 at about 17.30 hrs received a secret source information that one person namely Laxman Singh (20/M) S/O Kapil Singh of Jyotinagar, Charak Math, Ward No. 04, PS- Siliguri, Dist- Darjeeling has stored huge quantity of Illicit distilled liquor at his house without any valid license. Diarized the matter accordingly informed the matter to O/C KhalparaTOP. and as per kind direction of O/C myself along with force left for Jyotinagar, Charak Math under Siliguri PS to verify the veracity of the source information. On reaching at the spot at 17.50 hrs it was found that huge quantity of Illicitly distilled liquor has stored in the house of Laxman Singh who has also been selling the same to the common buyers. On being seen the police party the common customers fled away from the backside of the house. But we apprehend the above noted person namely Laxman Singh (20/M) S/O Kapil Singh of Jyotinagar, Charak Math, Ward No. 04, PS- Siliguri, Dist- Darjeeling in the very presence of those witnesses I search the house and seized the above noted Illicitly distilled liquors after preparing proper seizure List duly signed by the two independent witnesses and apprehend the person namely Laxman Singh On being asked the said person failed to produce any document for selling and storing liquor at the house. It's a violation under Bengal Excise Act. This seizure was made on 05.03.23 in between 18:10 hrs to 18:25 hrs. Label was also prepared against total seized articles. I then arrested the accused Person namely Laxman Singh (20/M) S/O Kapil Singh of Jyotinagar, Charak Math, Ward No. 04, PS- Siliguri, Dist- Darjeeling after preparing memo of arrest and intimating the ground of arrest. On being asked by police he stated that he running this illegal business of liquor at the said Shop and selling the same to the common customers since last few months without any license or permission of appropriate authority.

Therefore I pray before your good self that a specific case against the above noted accused person namely Laxman Singh (20/M) S/O Kapil Singh of Jyotinagar, Charak Math, Ward No. 04, PS- Siliguri, Dist- Darjeeling may kindly be initiated under proper section of law and may cause for its investigation.
