In producing herewith two accused persons namely (1) Moni Roy (30), S/O- Kalipada Roy of Purba Chayanpara PS Bhaktinagar Dist. Jalpaiguri and (2) Sagar Barman (33) S/O Andhiram Barman of Farabari Adarsha Pally PS New Jalpaiguri Dist. Jalpaiguri and the following articles under seizure:

i. 14 (Foreteen) bottles of "60 UP HIMALAYAN GOLD INDIA MADE LIQUOR " each bottle containing 600 ML, MRP Rs. 155/- (Total- 8.4 Liters & Amount Rs 2170/-).

ii. 06 (Six) bottles of "HAYWARDS 5000 PREMIUM STRONG BEER " each bottle containing 650 ML, MRP Rs. 125/- (Total- 3.9 Liters & Amount Rs 750/-).

I ASI Krishna Ch Singha of Ashighar OP PS Bhaktinagar lodged a written complaint against the accused persons namely (1) Moni Roy (30), S/O- Kalipada Roy of Purba Chayanpara PS Bhaktinagar Dist. Jalpaiguri and (2) Sagar Barman (33) S/O Andhiram Barman of Farabari Adarsha Pally PS New Jalpaiguri Dist. Jalpaiguri to the effect that, today i.e. 04.03.2023 I along with C/1181 Bhoresh Ch Roy and C/973 Kushal Roy while performing evening mobile van duty at Ashighar OP Jurisdiction, Vide Ashighar OP GDE no. 100 Dated 04.03.23 & MCC no. 264/23 dated 04.03.23 in course of said duty I received information from my source that two persons namely Moni Roy and Sagar Barman are carrying huge quantity of liquor inside a bag and coming from Baneshwar more to Farabari side through Eastern bypass to sell illegally to the local youth of Farabari area in higher rate for their wrongful gain. I immediately informed O/C Ashighar OP over mobile phone and as per his kind direction wasting no time I along with my accompanied party ambushed at Bhari More, Eastern Bypass to verify the veracity of information and after some times found two (02) persons coming from Baneshwar More side towards Bhari More Eastern Bypass carrying a bag by hand one of them. Seeing the Police party the said two persons tried to flee away, but we managed to intercept them. I searched the bag, in course of which I recovered the above noted bottles of liquor from their bag. On interrogation, the above noted persons disclosed their name and identity as noted above. On being asked, the above noted accused persons failed to produce any documents for such illegal possession of such articles. Accordingly I seized the above noted articles as alammah of the case, I also arrest the above noted accused persons u/s 41 Crpc for violating the provision of B.E Act. The Search and seizure and arrest were made in between 17.25 hrs and 18.05 hrs on 04.03. 2023.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons (1) Moni Roy (30), S/O- Kalipada Roy of Purba Chayanpara PS Bhaktinagar Dist. Jalpaiguri and (2) Sagar Barman (33) S/O Andhiram Barman of Farabari Adarsha Pally PS New Jalpaiguri Dist. Jalpaiguri under proper section of law and arrange for its investigation.
