
With due respect and humble submission I ASI Milan Gurung posted at Ghoshpukur Traffic as O/C Dist-Darjeeling. I would like to inform you that on 04.03.23 due to some urgent official work I was been to Siliguri, while returning home after completion of official work at about 20:30 hrs. I stop my car at Iscon more traffic obeying traffic signal, in the mean time one scooty bearing Reg No.WB74-BK-4749 coming from rear side and suddenly dashed on my vehicle bearing Reg No.WB-52AH-4137 following which my vehicle got damaged when I asked to the rider of the scooty about the incident he replied me "Toh kya hua (so what) again I tried to asked him to drive safely but he shouted on me "chup raho beshi bolega toh kat denga" I protect him as per law. He suddenly caught my collar and started to assault me physically by fist and blow in the mean time he took out some weapon from his scooty and attacked upon me. I fortunately safe from his with the help of my family members and the local people seeing the incident people of the surrounding, gather at the place of incident I was surprised and puzzle so that I could not contact to the concerned P.S. But I called to one duty traffic civic voluntary and they came to the spot when the offender see Police present he fled away from the spot. Sir, I verified his scooty number and found following particular: Name-Silajit Dutta S/O-Indrajit Dutta of Vila Samar Nagar road, near school, samar Nagar, Kalkut(P), Darjeeling-734003, a matter of prestige being a Police personal have to atrocity in the open public place, as because I was in civil dress.

I therefore request you to kindly look in to the matter seriously and take necessary strict action against the accused person as per proper proper Law to prevent such type of incident in future. In open public place and humiliation of Police prestige Law and justice.
