In producing herewith one arrested accused person named Babu Das (28) S/O- Lt. Manik Das, Matangini Colony, Tikiya Para, W/No- 28, PS- Siliguri, Dist- Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz: Ten (10) Sealed Bottles Himalayan Gold premium 60 Up Country Spirit each containing 600 Ml each labeled as Himalayan Endeavour PVT Ltd. Siliguri, West Bengal, in which one sealed bottle has taken from mother packet box as sample under proper seizure list, labeling and memo of arrest.

I, SI Basudeb Guha of Siliguri PS, (SPC) do hereby lodge this written complaint against the above noted accused person namely Babu Das (28) S/O- Lt. Manik Das, Matangini Colony, Tikiya Para, W/No- 28, PS- Siliguri, Dist- Darjeeling, to the effect that on 06/03/23 at 10:25 hrs acting on secret source information that the above noted person was busy to sale Id Liquor illegally at his house situated at Matangini Colony, Tikiya Para, W/No- 28, under Siliguri PS in order to clandestinely dispose the same. Accordingly I informed the fact to IC Siliguri PS and as per his direction I along with other officer and forces left for Tikiya Para vide Siliguri PS GDE no- 321 dated 06/03/23. On reaching at 10:50 hrs there and as identified by the source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we manage to apprehend the above noted person and on interrogation he disclosed his identity as noted above. On being asked he stated that he used to sale the 60 up country Spirit to locality without any valid documents as he violated the norms of Bengal Excise Act for selling the said Liquor without any valid License. On search recovered Ten (10) Sealed Bottles Himalayan Gold premium 60 Up Country Spirit each containing 600 Ml each labeled as Himalayan Endeavour PVT Ltd. Siliguri, West Bengal, in which one sealed bottle has taken from mother packet box as sample as per seizure list which was kept concealed in his Shop situated at Matangini Colony, Tikiya Para, W/No- 28. On being interrogation he could not produce any valid documents in respect of said liquor. He also stated that he is doing this Liquor business since long for his wrongful gain. Accordingly I seized the same in presence of available witnesses duly signed by them. The seizure and label was made in between 10:45 hrs to 11:05 hrs. As such I arrested him U/S- 41 Cr.P.C after observing all legal formalities.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Babu Das (28) S/O- Lt. Manik Das, Matangini Colony, Tikiya Para, W/No- 28, PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigation.
