Sir,

In producing herewith one arrested accused person named Niti Barman (31) w/o Manik Barman of Matigara Bhanga Pool, PO+PS- Matigara, Dist.-Darjeeling along with following articles under proper seizure list.

1. 11 (Eleven) Bottles of "80 UP PET HIMALAYAN TUK TUK INDIAN MADE LIQUOR" each Bottle containing 600 ml [Total 6.6 Ltrs] and marked as Exhibit "A" out of which 01 (One) bottle of "80 UP PET HIMALAYAN TUK TUK INDIAN MADE LIQUOR" each Bottle containing 600 ml. taken as sample for examination and marked as Exhibit "A-1".

3. 06 (Six) Pet Bottles of "IMPERIAL BLUE BLENDED GRAIN WHISKY" each Bottle containing 180 ml [Total 1.08 Ltrs] marked as Exhibit "B" out of which 01 (one) Pet Bottle of "IMPERIAL BLUE BLENDED GRAIN WHISKY" each Bottle containing 180 ml. taken as sample for examination and marked as Exhibit "B-1".

I, SI Sailesh Subba of Matigara P.S, SPC would like to lodge this written complaint against the above noted accused namely Niti Barman (31) w/o Manik Barman of Matigara Bhanga Pool, PO+PS- Matigara, Dist.-Darjeeling to the effect that today on 06.03.2023 at about 11.35 hrs I, received a specific source information that one Niti Barman is selling illicit liquor at her shop situated at Matigara Bazaar under Matigara PS. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 304, Dated 06.03.23 and informed the fact to the Officer-In-Charge, Matigara PS and as per his kind order and direction myself along with C/974 Mintu Sen, and CV/387 Sukumar Barman and LC/1286 Anisha Chhetri all of Matigara PS left for Matigara Bazaar, to work out the information in hand. After arrival at Matigara Bazaar and being identified by the source I along with force held raid at the shop of Niti Barman after maintaining the strict regard of her decency and managed to apprehend her. On being asked she disclosed her identity as noted above and also disclosed that she has been selling illicit liquor at her shop without any license for her wrongful gain. Further, on being searched the above noted illicit liquor was recovered from her house. On demand she failed to produce any valid license/papers for selling and storing of illicit liquor at her house. On further interrogation she stated that she has been involved in selling and possessing of illicit liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above noted person named Niti Barman (31) w/o Manik Barman of Matigara Bhanga Pool, PO+PS- Matigara, Dist.-Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 06.03.23 in between 11.50 hrs to 12.05 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case under proper section of law may kindly be initiated against arrested accused namely Niti Barman (31) w/o Manik Barman of Matigara Bhanga Pool, PO+PS- Matigara, Dist.-Darjeeling and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
