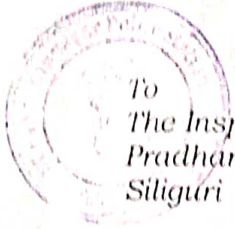

I SI Youel Lepcha of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 06.03.2023 in course K30 evening mobile van duty at PS area with force C/ 417 R.N Das and C/ 1413 S Sarkar vide PDN PS GDE NO 327/23 dtd.06.03.2023 at 19.55hrs I received an information that one person is possessing huge quantity of illegal liquor at Siliguri Junction under Pradhannagar PS .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and as pointed by the source we apprehended the above noted person and on search we recovered above noted articles , On demand apprehended person failed to produce any valid document in respect of recovered articles .On interrogation he admitted he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 20.25 hrs to 21.20 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Suklal Ghosh (30) S/O Lt Kartik Ghosh of Ganesh Ghosh Colony PS Pradhan nagar, Dist.Darjeeling and arrange for its investigation.
