

Hear by want to inform you that today near about 4:00 p.m one of my friend Bura call me on my cell phone and ask me to visit near Hotel Heritage to celebrate Holi festival but suddenly after reaching near Heritage Hotel at 4:30 p.m. while we were celebrating Holi festival persons naming Ram Bali, jiten Prasad and his friends without any reason hit me on my nose and eyes. Because of the pain of nose and eyes I can't even see anything but listening that they were shouting to kill me. As I was grounded helpless my friend Mrinal Barman recovered me from that place and took me to Siliguri District hospital. After the treatment I found that my gold neck Chain and cash rupees about 11500 missings . Myself I had that information that Ram Bali and jiten Prasad still searching me. I am very scared about my life .
So sir I am as victim requesting you to take necessary action to save me from getting murdered by these persons.
