Sir,

In producing herewith one arrested accused person named Gagan Roy (54) s/o Late Jogeshwar Roy of Sishudangi, Thakkar, Ward No.01, PS- Matigara, Dist.-Darjeeling along with following articles under proper seizure list.

1. 12 (Twelve) Bottles of "60 UP PET HIMALAYAN GOLD COUNTRY SPIRIT" each Bottle containing 600 ml [Total 7.2 Ltrs] and marked as Exhibit "A" out of which 01 (One) bottle of "HIMALAYAN GOLD COUNTRY SPIRIT" each Bottle containing 600 ml. taken as sample for examination and marked as Exhibit "A -1".

3. 04 (Four) Bottles of "SUPER JUBILEE SPECIAL WHISKY" each Bottle containing 375 ml [Total 1.5 Ltrs ] marked as Exhibit "B" out of which 01 (one) bottle of "SUPER JUBILEE SPECIAL WHISKY" each Bottle containing 375 ml. taken as sample for examination and marked as Exhibit "B-1".

I, SI Sailesh Subba of Matigara P.S, SPC would like to lodge this written complaint against the above noted accused namely Gagan Roy (54) s/o Late Jogeshwar Roy of Sishudangi, Thakkar, Ward No.01, PS- Matigara, Dist.-Darjeeling to the effect that today on 07.03.2023 at about 15:55 hrs while performing PC mobile van duty at PS area received a specific source information that one Gagan Roy (54) s/o Late Jogeshwar Roy of Sishudangi, Thakkar, Ward No.01, PS- Matigara, Dist.-Darjeeling is selling illicit liquor at his house situated at Sishudangi under Matigara PS. Accordingly, I informed the fact to the Officer-In-Charge, Matigara PS and as per his kind order and direction I, along with C/974 Mintu Sen, and CV/387 Sukumar Barman both of Matigara PS left for Sishudangi, PS- Matigara, Dist.-Darjeeling to work out the information in hand. After arrival at Sishudangi and being identified by the source we held raid at the house of Gagan Roy and managed to apprehend him. On being asked he disclosed his identity as noted above and also disclosed that he has been selling illicit liquor at his house without any license for his wrongful gain. Further on, being searched of his house recovered huge quantity of illicit liquor from his house. On demand he failed to produce any valid license/papers for selling and storing of illicit liquor at his house. On further interrogation he stated that he has been involved in selling and possessing of illicit liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above noted person named Gagan Roy (54) s/o Late Jogeshwar Roy of Sishudangi, Thakkar, Ward No.01, PS- Matigara, Dist.-Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 07.03.23 in between 16:20 hrs to 16:40 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case under proper section of law may kindly be initiated against arrested accused namely Gagan Roy (54) s/o Late Jogeshwar Roy of Sishudangi, Thakkar, Ward No.01, PS- Matigara, Dist.-Darjeeling and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
