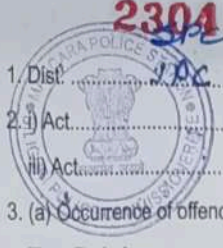

I, Muskan Mallick, aged about 20 Years, resident of Quater No. 261, Gate No. 5, New Rangia, under North Bengal University Campus, Near Boy's Hostel, P.O. - Shivmandir, T.S. Matigara, Dist. Darjeeling, want to lodge a written complaint before You on a matter that ~~two~~ three persons namely (1) Biswajit Barman @ Raja (2) Sanjay Roy and (3) Vivek Khawas, all of them are resident of local area of our Quater, that they used to tease me and use filthy languages all the time whenever I used to go outside, and if I told them to not to do such things, they threatened me by saying that they are very powerful and no one can do anything to them.

That ~~today~~ ^{yesterday} ~~while~~ ^{after} networking from my friends house, I came to know from my brother that my brother went to a nearby grocery shop and there the above named persons named (1) Biswajit Barman @ Raja (2) Sanjay Roy and (3) Vivek Khawas, they were using vulgar languages for me, and my brother then requested them not to use that type of languages. But then they started to beat my brother with bricks, stones, broken alvesters, sharp weapons etc. After ~~knowing~~ ^{hearing} that ~~on~~ later on 10 P.M. the said three persons along with many others came in front our house and started to shouting. After me and my brother came outside and

requested them not to do that, again they started
necessarily fighting with us. Again they beat my brother
-they also punched me behind my head, choked my
throat, and pushed me and I fall down.

While returning they threw stones at our
and threatened me by saying that they will kidnap
from my house and will vanish me.

Under above circumstances, I therefore
request You to kindly investigate into this matter and do
justice for the ends of Justice.
