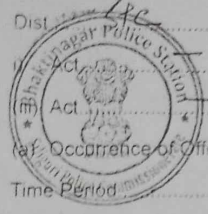

In producing herewith one accused person namely (1) Budhir Roy (38), S/O- Late Nobin Roy of Papiapara Thakurtala PO Ghogomali PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure:

- i. 18 (Eighteen) bottles of "THE STRONG KICK PREMIUM BEER" each bottle containing 650 ML, MRP Rs.125/- (Total- 11.7 Liters & Amount Rs 2250/-).

I ASI Amit Mallick of Ashighar OP PS Bhaktinagar lodged a written complaint against the accused person namely (1) Budhir Roy (38), S/O- Late Nobin Roy of Papiapara Thakurtala PO Ghogomali PS Bhaktinagar Dist. Jalpaiguri to the effect that, today i.e 06.03.2023 I along with C/1013 Sanjay Singha and CV/1034 Manojit Barman while performing morning mobile van duty at Ashighar OP Jurisdiction, Vide Ashighar OP GDE no. 137 Dated 06.03.23 & MCC no. 270/23 dated 06.03.23 in course of said duty I received information from my source that one person namely Budhir Roy is carrying huge quantity of liquor inside a bag and coming from Baneshwar more to Papiapara Thakurtala through Eastern bypass to sell illegally to the local youth of Papiapara Thakurtala area in higher rate for their wrongful gain. I immediately informed O/C Ashighar OP over mobile phone and as per his kind direction wasting no time I along with my accompanied party ambushed near Nag Nurshing Home, Eastern Bypass to verify the veracity of information and after sometimes found one person coming from Baneshwar More side towards Nag Nurshing Home Eastern Bypass carrying a bag by hand. Seeing the Police party, the said person tried to flee away, but we managed to intercept him. I searched the bag, in course of which I recovered the above noted bottles of liquor from his said bag. On interrogation, the above noted person disclosed his name and identity as noted above. On being asked, the above noted accused person failed to produce any documents for such illegal possession of such articles. Accordingly, I seized the above noted articles as alamath of the case, I also arrest the above noted accused person u/s 41 Crpc for violating the provision of B.E Act. The Search and seizure and arrest were made in between 12.55 hrs and 13.25 hrs on 06.03. 2023.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person (1) Budhir Roy (38), S/O- Late Nobin Roy of Papiapara Thakurtala PO Ghogomali PS Bhaktinagar Dist. Jalpaiguri under proper section of law and arrange for its investigation.
