Respected Sir,

With due respect and humble submission I beg to state that I Nawin Pradhan s/o Bir Krishna Pradhan, of Jentam, ~~West~~ Radhu Khandu, P.S Jentam Dist - West Sikkim like to inform you that I am the owner of Wagnor bearing reg. no. SK01TA 1249. Today on 6th of March 2023, at about 8:30 AM to 9:00 AM my above noted vehicle was coming from Gangtok to Siliguri and when reached 7th mile Sevoke Road near Bengal Sagar under Bhaktinagar P.S at that time WB 73 D 9832 (Boloro Pickup) vehicle rush and negligently hit my vehicle from the opposite side. As a result 3 persons who were boarded in my above noted Wagnor namely Binod Rai, Bikash Gupta, and Sagar Tamang were received grievous injuries and my driver namely Pranit Rai also received injuries. On the other hand Arjun Chettri who was sitting on the Boloro pickup vehicle also received grievous injuries. Later Bikash Gupta, Sagar Tamang and Arjun Chettri shifted to Anandaloke hospital and Binod Rai, Sevoke more, Siliguri where the attending doctor declared them brought death. Binod Rai and Pranit Rai were shifted to Siliguri district hospital where attending doctor declared that Binod Rai was brought death. After first aid Pranit Rai (driver of Wagnor) was discharged from the hospital. After this accident the driver of the offending vehicle bearing reg. no. WB 73 D 9832 fled away from the spot.

I pray before you that necessary legal action may kindly be taken against driver of the offending vehicle bearing reg. no. WB 73 D 9832.
