With due respect and humble submission I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against one Ajay Malakar-30yrs s/o Sachin Malakar of New Rangia, Shiv Mandir PS Matigara Dist Darjeeling person to the effect that on 06.03.23 at 18.05 hrs received a source information from 2nd Mile Check post, near auto stand under Bhaktinagar PS that one person just got down from Sikkim Bus with huge quantity of Sikkim wine in his possession and just try to left for Matigara for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-323 dated 06.03.23. As per your kind instruction immediately myself along with C/915 C.P.Adhikary, C/374 Debraj Biswas, CVF/014 Labannomoy Barman, proceeded to the PO to work out the information. Within five minutes we reached at the spot, sometimes after, being identified by the source our police party held raid and seeing the Police party the above noted person fled away from the spot. On hot chase failed to arrest him but recovered and seized the following articles from the PO:-

(1) 20 (Twenty) bottles of ROYAL BLUE Premium Whisky (Made in Sikkim) each bottle containing 750 ML which was kept in two paper cartoon.

During local enquiry it came to learn that the name of alleged person is Ajay Malakar-30yrs s/o Sachin Malakar of New Rangia, Shiv Mandir PS Matigara Dist Darjeeling. he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from the PO (The seizure was made in between 18.25 hrs to 19.20hrs)

I therefore request you a specific case may kindly be started against the accused person namely Ajay Malakar-30yrs s/o Sachin Malakar of New Rangia, Shiv Mandir PS Matigara Dist Darjeeling under proper section of law and arrange for investigation..
