bring to your notice that I am a resident of old Matigara  
Road, near Silla Mandir. Today afternoon when I was enjoying  
Holi festival with my friends, I received a call from my  
friends saying that there was an attack on my family,  
I rushed home to find that, I found my brother has been  
brutally beaten who is presently admitted in district hospital.

After enquiry I found that the group was led by  
1) Sanjay Singh (Bantha) S/o Gopal Singh, R/o Ratan Lal Basti  
2) Md. Mustafa S/o Md. Moushim, R/o Ratan Lal Basti  
3) Bipul Sonar S/o Manik Lal Sonar and others, R/o Ratan Lal Basti

The group attacked my shop, beaten my mother, cash available  
in the shop was looted, My house was broken, TV broken,  
cycle dismantled. They even attacked other houses. They  
even pelted stones, threw bottles. These miscreants were  
with rods, swords in their hands.

Therefore I request you to take immediate action  
against such miscreants. Our family is under threat. We are  
in a fear that they might attack.
