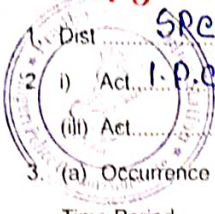

The incident took place at Dhooop Company more at Poodhan Nagar. But in due to some misunderstanding the above named along with other miscreants came directly and started using fist and blows upon us. On seeing

This the brothers of Anand Gupta and other people came for our rescue. and dispersed the crowd. Later again at evening the abovenamed along with some miscreants came and used fist, blows, bamboo, and some also brought pocket knife which we narrowly escaped. They even used blows to the corners of the house of Anand Gupta as they tried to rescue us and also threatened us with dire consequences. Poodeep Chowdhury and Lalun Mahato @ lalun snatched my gold chain.

Sir, in this incident. I had injury on my head (fore head).

Sir it is to mention, that all had weapons, tools such plus, Screedriver, bamboos, pocket knife and tried to kill us or seriously hospitalize us but somehow we escaped with the help of few peoples and later involvement of police personals.

Sir, the incident is very heinous and dangerous act from end of the abovenamed and other miscreants

Sir. I humbly request you take immediate and prompt action for the interest of public.
