

Sir,

I SI Satish Ruchal of Pradhan Nagar PS under Siliguri Police Commissionerate in here lodged this complaint against in accused persons namely (1)Siddhant Gupta (M/22 Yrs) S/o Birendra Prasad Gupta (2) Sourav Gupta (28 Yrs) Lt. Nagendra Prasad Gupta (3) Vishal Gupta (M/29 Yrs) s/o Birendra Prasad Gupta, all of Dhup Company Road, PS: Pradhannagar, Dist; Darjeeling to the effect that today i.e., on 08.03.2023, while I was performing K-30 evening mobile van duty accompanied forces C/207 Niladri Sarkar and C/883 Shyamal Biswas both of Pradhannagar PS vide Pradhan Nagar PS GDE No. 415/23 Dated. 08.03.2023 and MCC no.629/23 dated 08.03.2023 received an information from the Siliguri Control Room over RT set that some persons have been creating public nuisance at Dhup Company Road under Pradhan Nagar PS.

Subsequently, I along with force reached the spot at 20.15 and found the above noted persons were randomly creating problem and was assaulting randomly which proved dangerous in nature. Accordingly, I deputed my accompanied force and started to normalize the situation but in response the above-mentioned persons and other associates started discharging my public function as a public servant and assaulted and restrained by using criminal force. Hence, I arrested the accused persons noted above under proper Memo of Arrest and brought to Pradhan Nagar PS under SPC for further movement of the case. I also tried to arrest the other persons who was continuously obstructing my duty namely Pradip Chowdhury, Barreto and their associates but taking the advantage of the darkness, they fled away from the spot.

Under the above fact & circumstances I fervently request you to start a specific case against Siddhant Gupta (M/22 Yrs) S/o Birendra Prasad Gupta, (2) Sourav Gupta (28 Yrs) Lt. Nagendra Prasad Gupta, (3) Vishal Gupta (M/29 Yrs) s/o Birendra Prasad Gupta, (4) Pradip Chowdhury, (5) Barreto and their associates under proper section of law.
