Sub: - Written complaint against JAYA PRASAD SHARMA @ JAY PRASAD SHARMA, and his brothers, S/o Late Shiva Shankar Sharma, Resident of S.S Garage, Ward No:46, New Darjeeling More Hill Cart Road, P.O. & P.S. Pradhan Nagar, Dist : Darjeeling- 734003, along with local residential goons.

Sir,

With due respect I KEZHETHAYI PODIYAN VENU, S/o PODIYAN VENU, being the Proprietor/Owner of "DARJEELING TYRE'S", having its permanent business establishment at Ward No: 46, New Darjeeling More Hill Cart Road, P.O. & P.S. Pradhan Nagar, Dist : Darjeeling- 734003, would like to draw your kind attention to the following effect that I used to run my said business in the name of "DARJEELING TYRE'S", peacefully in the said premises/locality from the past 18 years, holding Permanent Certificate Of Enlistment issued by the Govt. of West Bengal [SMC] in the name of KEZHETHAYI PODIYAN VENU Bearing Certificate no: 0917P379222182105 issued on 23.05.2022 by the SMC, Siliguri, Darjeeling and is valid upto 22.05.2025 and also holding a GSTIN No: 19ACMPV4992L1ZF in the name of Pioneer Tyre Trading, and having the electricity connection in my name KEZHETHAYI PODIYAN VENU@ K.P. VENU electric connection provided by WBSEDCL having Consumer Id: 401862346 and also having a holding receipt issued by the SMC bearing Holding No: 110/37/OLD Receipt No: 10274 dated 15.05.2022. That while conducting the said business, I several time got threatened from the above named aforesaid persons that they will not let me run the said business in that particular area/ locality, as they are having a guilty intention/ill motive to capture the said shop for their business premises expansion in the said locality/area. It is pertinent to mention that the event of threat continued but I was always determined to run my said business to earn my livelihood/daily survival. But it is matter of grief to state that when after the hectic workload on 28.02.2023 at around 7.30 to 8.00 P.M. I Locked/closed my said shop with the shutter keys and 2 additional locks on two sides of the shutter and left for my house, but when I reached at my shop on next day i.e., 01.03.2023 I found out to my Knowledge that an Additional Lock was locked in the center part of the shutter, and while enquiring the said lock/event, I came to know that the said lock was put upon by the above named aforesaid persons with ill motive/illegal gain, when I asked them rather requested them to open it and what was the reason for such act, they said they will not open the lock of the said shutter and will grab/ illegally occupy the said shop and its nearby premises for their business expansion by Hook or by Crook, when the matter got heated up, the above named aforesaid person called their local goons from the area around 60 to 70 people gathered there and starting to threaten and starting physically abusing me by holding my collar, grabbing my face, putting hands on my body and holding my neck and by using filthy languages and stating that if I don't leave the premises/Shop they will take by life either by their physical or economical power. It is also pertinent to mention

that I am not being able to regulate the said shop of mine and inside the shop 36 different types of tyres holding and estimated value of Rs. 3,00,000/- [Three Lakhs ONLY], I tried to open the said shop on 02.03.2023 at around 10:30 A.M for unloading of tyres but failed to do so as the aforesaid persons and local goons didn't let me to open the said shop shutter. That due to non opening of the said shop it becoming a humongous task for me being a owner to run the said shop full fledgy as there is no scope for me to open the said shop as I have been restricted by the aforesaid persons and by his local goons, and due to this specific reason the Proprietor i.e., "DARJEELING TYRE'S", has faced and have been facing a humongous loss in the financial market, and for this the name of the shop/business as well as the repute of the owner is at a disastrous stake.

Some unintentional delay has appeared to lodge this complainant due to my mental stress and agony which had arisen for the said events/illegal act and activities of the aforesaid persons mentioned above.

So in view of above you are requested to take proper legal step / steps against the aforesaid persons and help me to reopen my said shop, or to take any other appropriate legal steps as per law.
