Subject: FIR against RAJNISH OJHA and other three persons.

Respected Sir,

With due respect, I GAYATRI PRASAD want to draw your attention, I am a resident of Champasari, beside Aanchal Office. My son ANURAG PRASAD is 17 years old studying in class 12 and giving his CBSE boards this year.

An incident of violence took place on Sunday 5 march 2023, 11:45 AM in front of the entrance of my house.

The name of the offender is RAJNISH OJHA who lives near our house. He started the violence, threatened my husband DINESH PRASAD to stab him to death when he will come to Siliguri and verbally abused him on the phone and in person in front of everyone in the area. When my husband came to Siliguri, he attempted to hit my husband and son with bricks and iron rod.

The offender first tried to hit my husband with bricks and stones. When my son tried to stop him, he tried to hit my son with bricks on his back but missed. He then hit my son with iron rod which injured my sons arm. He then stepped back and verbally abused me and my family and threatened to kill my son and my husband now (the violence was accompanied by his other three brothers). Few moments later he came and hit my sons right eye so hard that he started bleeding and he ran away. Later we came to know that my sons right eye was bleeding internally and got a fracture on the lower eye bone.

He also had his CBSE board exams the next day. The situation ruined his CBSE board exams, my academics and disturbed his mental health.

The offender RAJNISH OJHA is also suspected to be involved in multiple acts of violence with the neighbouring land owners.

We have got the CCTV footages, the images of injury and medical reports.

My son lives alone most of the time and he is not feeling safe with these kind of people walking freely. We request the authority to take strict actions against the offender RAJNISH OJHA as my son has been physically and verbally assaulted and make him pay for all this wrong doings and ensure that nothing wrong would happen in the future.
