Sir,

With due respect and humble submission, I beg to report that I, SI-Pradeep Diyali, presently posted at New Jalpaiguri PS, Siliguri Police Commissionerate would like submit this complaint to the effect that today on 02.03.2023 about 0245 hrs received an information from duty Officer ASI-Raju Subba of New Jalpaiguri PS, Siliguri Police Commissionerate that some people creating nuisance at New Jalpaiguri Hotel Line, out premises of New Jalpaiguri Railway Station as well as assaulted some employee of Hotel line and vandalised some stuff of Hotel. Accordingly, myself along with force, namely HG/794 Ranjit Roy, VP/08 Laxman Roy and CV/116 Rohit Kumar Mahato all are of New Jalpaiguri PS, Siliguri Police Commissionerate left for New Jalpaiguri Hotel Line to verify the veracity of the information and left for New Jalpaiguri Hotel Line outside premises of New Jalpaiguri Railway Station. After a while, myself along with force arrived at New Jalpaiguri Hotel Line and found that (i) Md. Sabnam Kamali s/o Md. Hira of Raja Holi, PS- New Jalpaiguri, Dist.- Jalpaiguri (ii) Subrato Ganguly @ Bappi s/o Sibu Ganguly of Bhaktinagar, Kathaltala, PS- New Jalpaiguri, Dist.- Jalpaiguri (iii) Babu of Bhaktinagar, PS-New Jalpaiguri, Dist.- Jalpaiguri (iv) Birju Sarkar and others creating nuisance, threatening Hotel Staff with dire Consequences and vandalized some Hotels Stuff such as Chair, Table etc and assaulted the hotel employee located at New Jalpaiguri Hotel Line. Subsequently, I informed SI- Dipenkar Chakraborty who is detailed to perform Night RT Van vide New Jalpaiguri MCC No.- 380/23 dated: 01.03.2023 to come to New Jalpaiguri Hotel line, out side premises of New Jalpaiguri Rail Way Station to assist me to prevent any untoward incident as the Law & Order can't be ruled out. At about 0315 hrs SI-Dipankar Chakraborty arrived at Spot and myself along with SI Dipankar Chakraborty and force tried several times to resist the above noted accused person and advised them to go home but they all are in vain and they refused to obey our order, instead they pelted stone against us and hindrance to discharge public service. When we tried to arrest them they fled away from the spot. Further, I, request several time to the several people of New Jalpaiguri Hotel Line area to come forward and submit compliant against the above noted accused persons but they failed to submit any complaint regarding this incident till this time. Hence, as per order of my superior, I, submit complaint against the above noted accused person regarding the incident.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the above noted accused person namely (i) Md. Sabnam Kamali s/o Md. Hira of Raja Holi, PS- New Jalpaiguri, Dist.- Jalpaiguri (ii) Subrato Ganguly @ Bappi s/o Sibu Ganguly of Bhaktinagar, Kathaltala, PS- New Jalpaiguri, Dist.- Jalpaiguri (iii) Babu of Bhaktinagar, PS-New jalpaiguri, Dist.- Jalpaiguri (iv) Birju Sarkar and others and arranged for its investigation.
