With due respect, I am producing herewith one arrested accused person namely Kamal Roy (35) S/O Krishna Roy of D.S Colony, P.S- NJP ,Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 08 (Eight) bottles of Himalayan Gold Country Spirit 60 UP country Spirit (each bottle containing 600 ml.)
2. 07 (Seven) bottles of Himalayan Fata Fati 70 UP country Spirit (each bottle containing 300 ml.)

I, ASI-Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 02.03.2023 at 18.45 hrs I received a secret source information that one person namely Kamal Roy (35) S/O Krishna Roy of D.S Colony, P.S- NJP ,Dist.- Jalpaiguri is selling ID liquor illegally at his shop at Netaji More, under NJP P.S. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 79 date: 02.03.2023 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 laxman Roy, CV/306 Biswajit Roy all of NJP PS, SPC left for Netaji More, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At 19.05 hrs we arrived at Netaji More, under New Jalpaiguri PS, Dist.- Jalpaiguri and being identified by the source I held raid the shop where the above noted accused person selling ID Liquor . Accordingly as per the indication of Source I managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 19.35 hrs to 20.05 hrs on 02.03.2023

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Kamal Roy (35) S/O Krishna Roy of D.S Colony, P.S- NJP ,Dist.- Jalpaiguri and arrange for its investigation.
