The same was received on 22nd February 2023 at Reliance Digital Warehouse, located at, Plot No 28 To 32 Kh No 1051 3/5/9 /13/18/19 Under Pargana Baikhuntapur, Mouza Binnaguri Po Bhaktinagar, JALPAIGURI - 735135, through Blue Dart Express Ltd (Courier Service).

We have received 3 boxes in tampered/seal open condition. On being suspicious, the same was opened in presence of the courier representative personnel and 07 handsets were found missing. Instead, we have received parts of bricks, placed inside, the same way. We have checked the CCTV footage also, the total value of missing items (Apple iPhone 14 128GB Blue) is Rs. 433,694.45/- were detected as stolen.
