Sir,

In producing herewith one arrested accused person namely Santosh Das @ Bhola (21yrs), S/o - Jogesh Das of Balaram Hat, PO. Balaram Hat, PS - NJP, Dist - Jalpaiguri along with the following seized articles as per proper seizure list:

1. 05(Five) sealed bottles of Himalayan Gold 60 up pet each bottle containing 600 ML.
2. 10(Ten) sealed bottles of Bazigar 70 up IML each bottle Containing 300 ML.
3. One Plastic Bag.

1. ASI. Rabi Tamang of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted accused person to the effect that today on 03.03.2023 at 14:50 hrs. myself along with (1) C/1180 Susen Ray, (2)NVF-130 Dhanadeb Ray, (3) HG-1158 Niten Ray, (4)LCV-423 Sampa Bhowmik and (5) LCV-325 Sabita Ray all of Ambari-Falakata OP, Under NJP PS/SPC left OP to conduct raid against illicit liquor at Ambari-Falakata OP area. This refers to Ambari-Falakata OP GDE No.100, dated: 03.03.2023. During raid duty at 16:25hrs I received a source information from Balaram Hat, Under Ambari-Falakata OP that the above noted accused person has gathered huge amount of liquor illegally for selling the same among the customers for his wrongful gain. Then myself along with above noted forces proceeds to Balaram Hat area to work out the information. At 17:05 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the local area, situated at Balaram Hat and recovered the above noted articles from the possession of accused person namely Santosh Das @ Bhola (21yrs), S/o - Jogesh Das of Balaram Hat, PO. Balaram Hat, PS - NJP, Dist - Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person in presence of witnesses namely 1) Abhijit Majumdar S/o. Lt. Ashim Majumdar of Ambari-Falakata, PO. Kamarvita, PS - NJP, Dist - Jalpaiguri and 2) CV-01 Joychand Roy of Ambari-Falakata Out Post, Under NJP PS/SPC after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made in between 17:25hrs to 17:55 hrs. Then I arrested the said noted accused person u/s 41 Cr.P.C. and issued him Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Santosh Das @ Bhola (21yrs), S/o - Jogesh Das of Balaram Hat, PO. Balaram Hat, PS - NJP, Dist - Jalpaiguri under proper section of law.
